**Public Offering of Subsurface Mineral Crown Dispositions**

Crown dispositions granted pursuant to this Notice are for subsurface minerals as defined in *The Subsurface Mineral Tenure Regulations* ("the Regulations") and shall be subject to applicable Acts and the Regulations.

**Bid Information**

Submitted sealed bids may not be considered if they do not conform to **BID TYPE I (Standard Bid)** shown on page 4. ER reserves the right to reject any or all received bids.

**Each sealed bid for a permit block must be enclosed in a separate envelope with a clearly marked mailing label on the outside as follows (refer to page 5 for example):**

- Permit Block Number

After the bidding period expires, the minister shall issue a permit to the person or company who:

- a) Submits the highest bid;
- b) Pays the rental for the first year of the permit as set out in subsection 10(1) of the Regulations;
- c) Pays all applicable taxes relating to rentals and bids; and
- d) Meets all other requirements of *The Crown Minerals Act* and the Regulations.

Please ensure that a representative is available the day after the Public Offering closing date. In the event of tied bids, ER will contact the concerned parties and provide them the opportunity to offer a new bid amount within a prescribed timeframe.

## **Pre-authorized Debit Payment**

Payment of this invoice will be withdrawn from the invoiced BAID's PAD bank account three days after the Public Offering closing date.

## RESTRICTIONS

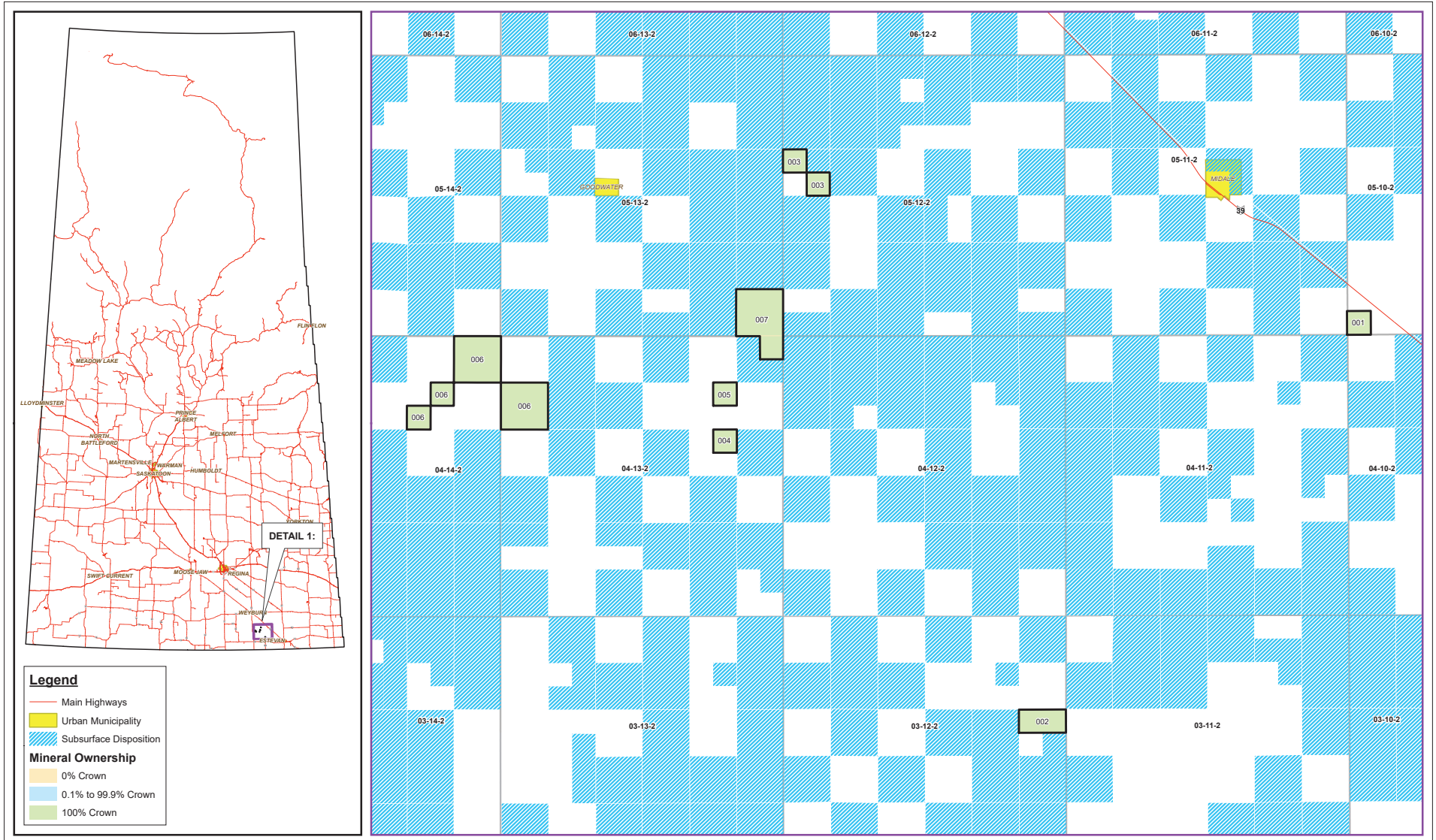
**CA** ABANDONED UNDERGROUND COAL MINE - This area contains several abandoned underground coal mines. Prior to any drilling operations, the Lands and Mineral Tenure Branch of the Ministry of Energy and Resources should be contacted to determine the location of any underground mines near the proposed drilling site.

**3KM** These lands either in whole or in part are located within 3 kilometres of an active potash disposition and require that the Ministry of Energy and Resources and the holder of the potash disposition receive a 30-day written notice from the well licence holder prior to the commencement of all drilling operations pursuant to Subsection 3(2) of *The Subsurface Mineral Conservation Regulations*.

**PNG** These lands either in whole or in part are subject to an oil and gas disposition issued under The Oil and Gas Tenure Registry Regulations. No holder of a subsurface permit shall interfere with oil and natural gas, helium and associated gases, oil sands or oil shale operations or any storage, injection or disposal operations.

The work requirement for the permit block is to be completed by the end of the permit term (8 years, or 8 years plus an approved extension period as per section 9(2) of The Regulations), and does not have to be completed annually. Please see sections 11 through 17 of the Regulations for more information on permit work expenditures.
